available in English, German, Lithuanian, and Swedish.

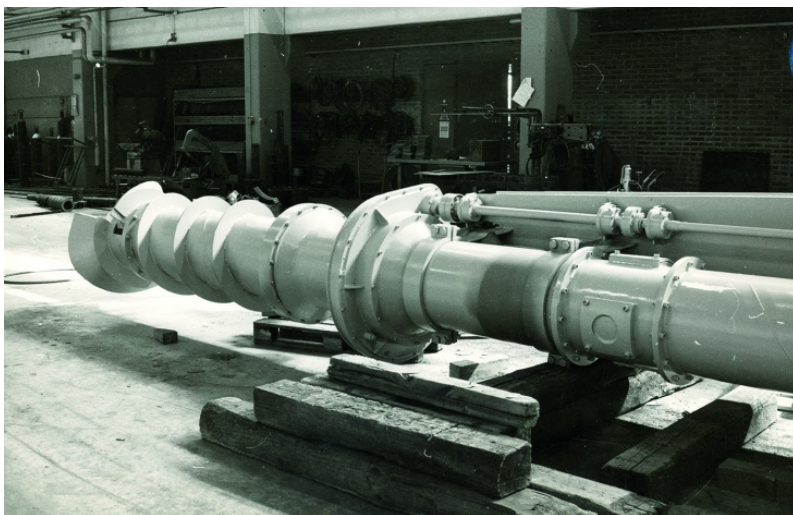
